## LEGAL ISSUES Court Procedures

### Steps in a Divorce Proceeding:

- 1. Preliminary Injunction with service
- 2. Case Management Conference (with kids)/Status Conference (without kids)
- 3. Mediation (private or court alternative dispute resolution)
- 4. Status Conferences
- 5. Judicial Settlement Conferences
- 6. Trials
- 7. Post-Judgment Motions

# LEGAL ISSUES Discovery

Discovery is the legal process of obtaining information from the opposing party.

#### **Methods of Discovery:**

- A. Financial Statements (M.R.Civ.P. 108(c))
- B. Request for Interrogatories/Request for Production of Documents
- C. Subpoenas
- D. Depositions

### What types of documents?

"a party may obtain discovery on issues of spousal and child support, counsel and guardian ad litem fees, and disposition of property and debt as in any other civil actions."



# LEGAL ISSUES Temporary/Interim Orders

### Temporary Orders Pending Divorce/Interim Orders:

- 1. What happens while the divorce is pending?
  - 1. Where do kids live? When does the other parent see them?
  - 2. Who pays on-going bills?
  - 3. Spousal support and child support orders for financial needs
  - 4. Possible pre-division of marital assets and bank accounts, if necessary
  - 5. Attorney's fees?
- 2. When and how can you request these orders?

#### What if I need immediate help for safety?

1. Protection from Abuse Orders— different process, but can have some overlap



# LEGAL ISSUES Overview of Legal Concepts

### BEST INTEREST OF THE CHILD: 19-A M.R.S.A §1653(3)

- Physical "primary" residency
- Decision-Making major decisions- school, religion, sports, etc.
- Child/Parent Contact Schedule
- Modification of contact schedules
- How disputes are handled

- 1. Who qualifies to receive spousal support?
- 2. How long does the spousal support award last?
- 3. How can spousal support be modified?
- 4. Can wages be garnished?
- 5. How is spousal support taxed?
- 6. What happens if someone is willfully unemployed or underemployed?

### LEGAL ISSUES Health Insurance

- 1. Effect of the Preliminary Injunction of Health Insurance coverage
- 2. Can existing health insurance coverage continue after the divorce is finalized?
- 3. What options do uninsured individuals have if they previously were covered by spouse?
  - 1.COBRA (Consolidated Omnibus Budget Reconciliation Act)
  - 2. Employer sponsored plans
  - 3. Health Insurance Marketplace https://www.coverme.gov/
- 4. Who covers the kids?



## LEGAL ISSUES Property Division

### First question: Is this property marital or non-marital?

- 1. Personal Property (tangible objects, furnishings, etc.)
- 2. Real Estate (marital home, investment properties, rental properties, etc.)
- 3. Retirement/Pension accounts (401K, IRA, 403(b))
- 4. Debt (mortgage, car loans, credit cards, personal loans)
  1.What about student loans?
- 5. Businesses (valuation)

### LEGAL ISSUES CHOOSING AN ATTORNEY

#### \*YOUR GOAL SHOULD BE FINDING SOMEONE YOU TRUST & ARE COMFORTABLE WITH\*

- 1. Ask friends, other professionals you work with, etc. for recommendations
- 2. Ask about free consultations or phone meetings
- 3. At your initial consultation, go prepared with questions and basic information about your property
- 4. Interview multiple attorneys, if possible
- 5. After hiring, maintain communication with your attorney!



### LEGAL ISSUES Attorney's Fees

### Payment of Attorney's Fees:

- 1. How much is a typical retainer and hourly rates?
- 2. Who pays for these fees?
- 3. Can the other party pay for my attorney's fees?
- 4. Can you use marital property to pay for attorney's fees?
- 5. If you borrow to pay an attorney, who is responsible for the debt?
